We'll be starting with our low vision services. What is low vision and how might it affect each and every one of us? The answers to these questions and other commonly asked questions about low vision are addressed in this newsletter. The FCAB addresses the needs of those with low vision by demonstrating various low vision aids, such as magnifying and telescopic lenses, large print materials, talking watches and telephones, and CCTVs. A low vision clinic is conducted on a regular basis for eligible clients. The clinic allows the client to meet with a low vision specialist and talk personally about what assistive aids might help them to move through life's activities more easily. Shirley Workman coordinates the low vision services.

Enclosed with this newsletter, you will find a broadband outreach survey which is being conducted through the state of Pennsylvania. The purpose of the survey is to find out where additional access technology is needed to reach the visually impaired throughout the state. As we all know, technology has become key in keeping us all informed of an emergency. Anyone can complete this survey, you do not have to be visually impaired. If you'd like, call the association and we will complete it for you over the telephone. Just a little bit of your time and effort will help in moving this cause forward.

READ ON FOR A NEW VERSION OF KINDLE FOR BLIND AND LOW VISION PC USERS.

Amazon.com is releasing a new version of Kindle for PC that adds accessibility features designed for blind and low-vision customers.

Kindle for PC with Accessibility Plugin is a free, downloadable application for your Windows PC. It provides the following accessibility features:

- text-to-speech reading with adjustable voice settings, voice-guided menu navigation, large font sizes, high contrast reading mode, keyboard navigation, and accessible shortcuts.

With this software, for the first time ever, the entire collection of English language books in the Kindle Store can be read aloud. With over 750,000 English language titles, Amazon offers the largest selection of accessible ebooks. In order to use the text-to-speech feature, an external screen reader program must be installed and running on the Windows PC.

FACTS ABOUT LOW VISION

What is Low Vision?

Low vision means that even with regular glasses, contact lenses, medicine or surgery, people find everyday tasks difficult to do. Reading the mail, shopping, cooking, seeing the TV, and writing can all be challenging to the person experiencing low vision. But, many people are learning that they can take charge of their low vision concerns by using devices and services that help them continue to be independent.

Is losing vision just a part of going older?

Not necessarily. Most people develop low vision because of eye diseases and health conditions, such as Macular Degeneration, cataract, glaucoma and diabetes. While vision that's lost usually cannot be restored, many people can make the most of the vision they have.

Your eye care professional is the best person to tell you if vision loss is due to normal changes in aging or a particular health condition.

How do I know if I have low vision?

You should have regular dilated eye exams to determine your eye health, but there are many signs that can signal vision loss. For example, even with your regular glasses, do you have difficulty:

- Recognizing faces of friends and relatives?
- Doing things that require you to see well up close, like reading, cooking, sewing, or fixing things around the house?
- Picking out and matching the color of your clothes?
- Doing things at work or home because lights seem dimmer than they used to?
- Reading street and bus signs or the names of stores?

What can I do to take charge of my low vision?

Talk with your eye care professional and get more information about devices and services that may help you. Visual devices such as magnifying lenses for close-up viewing or telescopic lenses for seeing in the distance, and training on how to use them, may be available to you.

If your eye care professional says, "Nothing more can be done for your vision," ask about vision rehabilitation. These programs offer a wide range of services, such as low vision evaluations and special training to use visual and adaptive devices. They also offer guidance for modifying your home as well as group support from others with low vision.

Can the Fayette County Blind Association help me with my low vision needs?

Yes, the staff at FCAB will do everything possible to assist you with your low vision needs. We have various devices and services available on site. If necessary, we can also link you to other resourcesall leading you toward the path of independence. In Memory of Byronetta McGaughey

Byronetta McGaughey, former Executive Director of the Fayette County Association for the Blind, passed away this past November. Byronetta served as the Executive Director from November 1960 through July 1977. During her tenure, the Prevention of Blindness Program was started. This program is still in operation today and serves to provide vision screening to over 1000 children each year.

It was also during Byronetta's tenure that a highly successful local fund-raising campaign produced a new building for the blind association, which today remains home.

BROADBAND OUTREACH SURVEY

Dear Friend,

We are requesting your help in addressing the need for a more efficient means of communication and support to all Pennsylvanians with a visual impairment, especially those located in rural areas, such as Fayette County. **By completing this quick outreach survey, you will help determine where the need for additional technology access exists throughout Pennsylvania. You do not need to be visually impaired to complete the survey.**

We all know that satisfactory quality of life, including a minimum level of safety and independence, is enabled by technology and real-time communication. Many blind and visually impaired individuals, because of income level, rural location or age, do not have access to broadband and/or a computer connection. In order to connect these individuals and keep them independent in their homes, the state of Pennsylvania, in cooperation with the Pennsylvania Association for the Blind, is conducting this survey.

In addition, through a partnership with local chapters of the American Red Cross, several Outreach Programs will be held throughout the state to educate and survey blind individuals, family and friends for two purposes: to obtain adequate information of current broadband connectivity, and educate the community of appropriate emergency preparedness management. Further information on these outreach programs will be available at a later date.
